

# TRAFFIC SAFETY SCHOOL

For drivers **under the age of 21** who personally appear in court and receive court supervision for any moving violation will additionally be required to attend Traffic Safety School. Registration for Traffic Safety School can be done in the Circuit Clerk's office. There is an additional fee of **\$45.00** for this school which must be paid at the time of registration. Failure to complete Traffic Safety School within one's period of court supervision **will result in conviction.**

For drivers **under the age of 18**, a parent or legal guardian must personally appear in court with the driver. Drivers under the age of 18 who receive court supervision for any moving violation will also be required to attend Traffic Safety School. Registration for Traffic Safety School can be done in the Circuit Clerk's office. There is an additional fee of **\$45.00** for this school which must be paid at the time of registration. Failure to complete Traffic Safety School within one's period of court supervision **will result in a conviction.**
