**DEFENDANT'S MOTION TO CLAIM EXEMPTION
UNDER
WAGE DEDUCTION PROCEEDINGS**

Now comes _____ defendant in the above entitled cause and moves this Court to find his/her wages to be exempt for the following reason(s).

1. The amount of wages that are being deducted:

- is greater than (A) 15% of my gross weekly wages or (B) the amount by which disposable earnings for a week exceed the total of 40 times federal minimum hourly wages.
- is greater than (A) 25% of disposable earnings for a week or (B) the amount by which disposable earnings for a week exceed 30 times the federal minimum hourly wage.
- include pension and retirement benefits and funds.
