I hereby petition the court to rescind the Statutory Summary Suspension heretofore issued in this case due to the issue(s) of: [check appropriate item(s)]

- ( ) I was not properly placed under arrest for an offense as defined in Section 11-501 of the Illinois Vehicle Code (Driving Under the Influence of Alcohol/Drugs) or a similar provision of a local ordinance, as evidenced by the issuance of a Uniform Traffic Ticket to other form of charges.
( ) The arresting officer did not have reasonable grounds to believe that I was driving or in actual physical control of a motor vehicle while under the influence of alcohol and/or drugs, or a combination thereof;
( ) I was not properly warned by the arresting officer as provided in Section 11-501.1 of The Illinois Vehicle Code;
( ) I did not refuse to submit to and/or complete the required chemical test or tests, pursuant to Section 11-501.1 of the Illinois Vehicle Code, upon the request of the arresting officer;
( ) I submitted to the requested test or tests but the test sample of my blood alcohol concentration did not indicate a blood alcohol concentration of .08 or more.

The hearing will be held within 30 days after receipt of the Petition to Rescind Statutory Summary Suspension but, subject to the discretion of the court, not sooner than 7 days following receipt of such petition by the circuit court having jurisdiction.
